Dear Mr. Purdie,

Dersingham - Hunstanton Road (A149) and Station Road Proposed Waiting Restrictions

Negotiations are well advanced for the installation of traffic signals at the Hunstanton Road/Station Road/Chapel Road junction in Dersingham and loop detection equipment will be installed in the carriageway at each approach to the junction.

It is essential that parking is prohibited on both sides of a road in an area where loop detection is installed and I therefore propose that an Order be made prohibiting waiting 'At any time' along the lengths of road coloured red on the attached plan which extend from the termination point of the current restriction westwards for approximately 35 metres on both sides of Station Road and southwards for approximately 35 metres on both sides of Hunstanton Road.

The existing restrictions, shown coloured blue on the plan, are adequate to cover the approach on Chapel Road and on Hunstanton Road from the north.

The Chief Constable informs me that he supports this proposal and I shall be obliged if I may now have your authority for it to be advertised. The advertisement will include a note to the effect that the proposed Order will not be implemented until the traffic signals are brought into operation.

Should you have any reservations about the proposal, please discuss the matter with Dr. Wilkes. I would also appreciate your view on the likely local public reaction to the proposal.

I attach, for your convenience, a duplicate copy of this letter together with a business reply envelope.



THE NORFOLK COUNTY COUNCIL (DERSINGHAM) (PROHIBITION OF WAITING) ORDER 1983 Report of County Surveyor

1. Background

In association with a large housing development off Station Road, Dersingham (C87), to the west of the A149, the developer has undertaken to finance the installation of traffic signals at the Hunstanton Road (A149), Chapel Road (B1440), Station Road junction.

The the traffic signals will require loop detection equipment set into the carriageway surface at each approach to the junction and, for the proper functioning of this equipment, it is essential that vehicles have an unrestricted approach to the signals without having to deviate around stationary vehicles.

The waiting prohibitions currently in force are adequate to cover the approach to the junction on Chapel Road and on Hunstanton Road from the north but it will be necessary for the existing prohibition of waiting to be extended for approximately 35 metres southwards on both sides of Hunstanton Road and for approximately 35 metres westwards on both sides of Station Road.

2. Proposal

With the agreement of the Local Member and the Chief Constable a proposal was advertised on the 8th July 1983 to prohibit the waiting of vehicles at any time on both sides of A149 Hunstanton Road from a point 36 yards south of Station Road (the termination point of the existing prohibition) southwards for approximately 35 metres and on both sides of Station Road from a point 18 yards west of A149 Hunstanton Road (the termination point of the existing prohibition) westwards for approximately 35 metres. The existing and proposed waiting restrictions are illustrated on the plan attached as Appendix I.

3. Objections

In response to this advertisement the following objections have been received:-

3.1 Mr. J. A. French of 52, Hunstanton Road, Dersingham.

<u>Objection</u>

a) As owner occupier of the above address, a mid terrace house without garage space and no possible access for one to be built, I object to the siting of traffic signals as they

The proposed restrictions will prevent Mr. French from parking his car immediately in front of his house, however they will terminate some 15 metres to the south of his

- e) The signals will cause traffic congestion on Sundays during the summer.
- f) If these signals are so essential why have Ingoldisthorpe, Snettisham and Heacham not had signals installed as traffic through these junctions must be equal to or greater than through Dersingham.
- g) Our house, without parking space, will be worthless when a time comes to sell the property and there will be no space for visitors to our house to park their cars.
- h) Instead of having a constant flow of traffic, it will be stopping and starting outside our house all night and we shall need soundproofing and double glazing free of charge and also a reduction in rates.

Entry to the A149 will be easier and safer from Station Road and Chapel Road. Traffic on the A149 will not be unduly disrupted.

The signals are to be installed to accommodate the additional traffic arising from the new housing development off Station Road.

See 3.2 (a).

It is unlikely that traffic noise will increase. As no alterations to the carriageway are involved the objector will be unable to claim for soundproofing or similar works to be undertaken at the Council's expense.

3.3 Mr. J. D. Cross of 48 Hunstanton Road, Dersingham

a) If the proposed 35 metre the east of extension on side Hunstanton Road is to be carried out, would it please be possible to extend this by a further 5 metres to include the entrance to our property this is frequently used by various vehicles. Our entrance will be at the immediate end of the proposed restricted area and it is most probable that vehicles will park across it.

The additional small extension would not only help to keep our entrance clear but would ensure that no vehicles were parked on the approach to the existing bus stop.

Such an extension would no doubt of benefit to Mr. Cross. However, it would be a legal Council necessity for the advertise a proposal to prohibit parking over this additional length of the east side of Hunstanton Road.

3.4 Mr. and Mrs. T. A. Gore of 25A Hunstanton Road. Dersingham

a) There are no waiting restrictions on the west side of Hunstanton Road between the northern boundary to the entrance to our property and the northern boundary of No. 31 Hunstanton Road.

In this vicinity there is a Fish Shop, a Newsagents and a Bus Stop in a space of about 30 yards and the queue of vehicles pulling up for these places is non stop from 5 am to 11.30 p.m.

At present we have to stand wooden boxes on the road side to allow Doctor and a nurse to gain entry and with proposed additional yellow lines everywhere else at the crossroads the additional vehicles parking in this unrestricted area will make it almost impossible for us to gain access to our property.

If this stretch of road remains unrestricted, vehicles will be more than ever pulling over from the other side of the road (from Hunstanton) causing accidents and more brake and tyre squeals than we have now.

May we ask that you extend these yellow lines to cover the complete strip from Station Road to Glebe Road.

The advertised proposals cover only the lengths of road over which waiting restrictions are essential in association with the installation of the new traffic signals.

Whilst consultations have taken place with representatives of the Parish Council and the Eastern Counties Omnibus Co. Ltd.. particularly with reference to any resiting of bus stops which might be desirable, but also with regard to any other amendments which might be necessry to waiting restrictions, it felt that these was additional matters should best be reconsidered once the traffic signals had been installed and the new traffic flow pattern could be monitored. would then be possible to submit proposals to overcome any problems which might arise.

3.5 Mr. and Mrs. P. R. Woods of 56 Hunstanton Road, Dersingham

a) We have parked immediately outside our property for 3.1/2 years and now find we will no longer be able to do so. This not only leaves us with the problem of where to park our car safely but the reduction in value it will cause to our property. b) Having no objection to the traffic lights themselves we ask the Council if they could find us parking close adequate рх failing that, permission to carry on parking as before.

The nearest length of road on which waiting will not be restricted is some 25 metres from Mr. Wood's house.

It will not be possible to make a special exception to allow Mr. Woods to continue to park his vehicle in front of his premises.

It is RECOMMENDED that:-

The Norfolk County Council (Dersingham) (Prohibition of Waiting) Order 1983 to prohibit waiting at any time on both sides of A149 Hunstanton Road from a point 36 yards south of Station Road southwards for approximately 35 metres and on both sides of Station Road from a point 18 yards west of A149 Hunstanton Road westwards for approximately 35 metres be made as advertised.
